SUPPLY, INSTALLATION, COMMISSIONING AND MAINTENANCE OF INTEGRATED CCTV FACIAL RECOGNITION SYSTEM FOR SRI LANKA AIRPORTS AND SEAPORTS

1. The **Chairman, Department Procurement Committee** on behalf of the **Sri Lanka Police** invites sealed bids from eligible bidders for the supply, installation, commissioning and maintenance of integrated cctv facial recognition system for sri lanka airports and seaports and Support and Maintenance period is Eight (8) years.
2. Bidding will be conducted through the **National Competitive Bidding (NCB- Two Envelope System: Single Stage - Two Envelope Bidding Procedure)** method specified in the **Procurement Guidelines 2024 on Goods, Works, and Non-Consulting Services**, and are opened to all eligible bidders as defined in the Guidelines

To be eligible for contract award, the successful bidder should not be blacklisted. Bidders must meet the following minimum qualification criteria for the contract award:

- a. **Specific Experience:**
The bidder shall have successfully completed and managed at least minimum of two (02) installations of IP Surveillance systems with minimum 100 cameras within the last 5 years prior to the bid submission deadline.
- b) **Average Annual Turnover:** Bidder should have minimum average annual turnover of **LKR 650 Million** within the last 3 years;
- c) **Financial Resource:** The Bidder must demonstrate access to or availability of financial resources such as liquid assets, line of credit and other financial means, to meet the cash flow requirement of not less than **LKR 90 Million**, and net of the bidder's other commitments for this project.

Bids will be opened soon after the bid closing in the presence of the bidders representatives, who choose to attend at **2.00 p.m 16.09.2025**. All bids must be accompanied by a Bid Security in the form of on bank guarantee of not less than **Sri Lankan Rupees 4,764,350.00**
