SLP conducts an investigation and issues this certificate to eligible citizens. This project aims to develop, host, and provide managed services for an online e-service to facilitate this process. Citizens submit applications for the Clearance Certificate through web portal. Department application to manage activities related to issuing the clearance certificate. This document details the requirements to be implemented through this eService. In addition to these services, applicants can check the status of their application and external stakeholders can validate if a certificate has been issued through SLP by inputting the NIC No, Passport No, and Certificate No of a clearance certificate. User management application to manage departmental users.**

Joint venture proposals are also welcome and will be considered. This invitation is non-transferable, and the procurement process will adhere to a single-envelope bidding procedure.**
